



**"Bitdefender BETA"
CONTEST TERMS SHEET**

The "Bitdefender BETA" contest, hereinafter referred to as the "Contest", is offered by BITDEFENDER SRL, with the registered office having the address **Bucharest, 2nd district, 24 Delea Veche Street, Offices Building A**, registered in Bucharest Trade Register Office town, under registration number **J40/20427/06.12.2005**, fiscal code: **RO 18189442**, legally represented by **Mr. Florin Talpeş**, as President, hereinafter referred to as the "Bitdefender"

A.1. CONTEST PERIOD

The period when the Contest will take place ("Contest Period") is between **May 22 2017, 07:00 PM (GMT +2)** and **June 29 2017, 07:00 PM (GMT +2)**.

A.2. Territory: Globally, except where prohibited or restricted by law.

A.3. ENTRY. For the registration in the Contest, the participants must follow the next steps:

A.4. CONTEST MECHANISM

The participant, being logged in on the Bitdefender Central beta page, can download the kits for Windows, Mac OS or Android and test their functionalities. In order to win one of the Campaign Prizes the participants must submit feedback by entering the Feedback page on beta.central.bitdefender.com and sign in with an existing account or create an account with the following data: Email Address.

The participants need to download the kits and install them. The participant must be logged in every time a bug is submitted, otherwise his/her contribution cannot be taken into account.

The participant must submit at least one idea (improvement or bug) on the Feedback Page on beta.central.bitdefender.com, in order to be eligible to win one of the Campaign prizes described below.

Participants may not enter with multiple emails and/or multiple identities nor may participants use any automated entry mechanism or artifice to obtain more than the maximum number of entries. Any participant who attempts to participate with multiple emails and/or multiple identities or uses any device or artifice to obtain more than the maximum number of entries will be disqualified.

The prizes of the Campaign will be awarded after analyzing during July 1 - July 10 2017 period which participant had the most valuable activity (the submitted feedback must be relevant, not duplicated, and communicates a real problem).

The awards will be made under the direct supervision of a committee formed by a representative of the Organizer (a member of the jury) and a lawyer chosen by the Organizer, who will draft the prizes awarding report, on July 10, 2017 at 7,00 pm (GMT + 2).

The winners will be announced by the Organizer through their e-mail address that they used to participate at the present Campaign. The winners will be also listed on the Campaign landing page: <http://www.bitdefender.com/beta2018/>.

If within 5 days, the winners fail to respond to the e-mail of the Organizer, next winner in line shall be chosen and the cycle is repeated only once.

Bitdefender activation codes described at section 4 from above are in electronic format (electronic key) and will be sent by Bitdefender to the winners via email to the email addresses used by participants at registration in the Campaign.

The confirmation of reading the email by the participants will be considered proof of receipt of the licenses.
